### Historical yield 6.2%

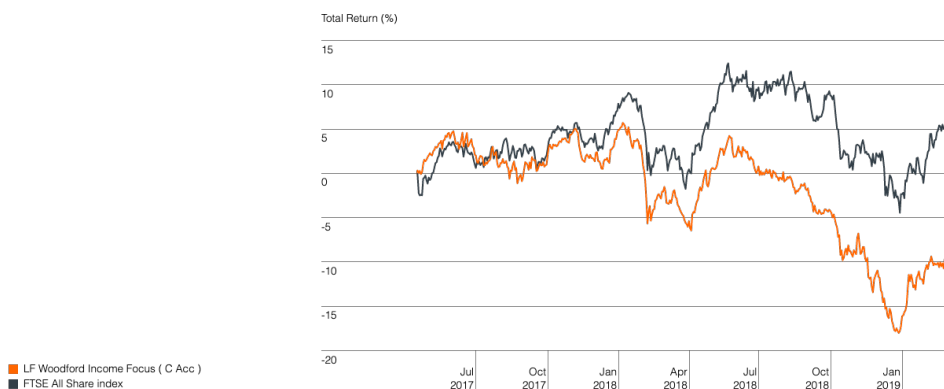
